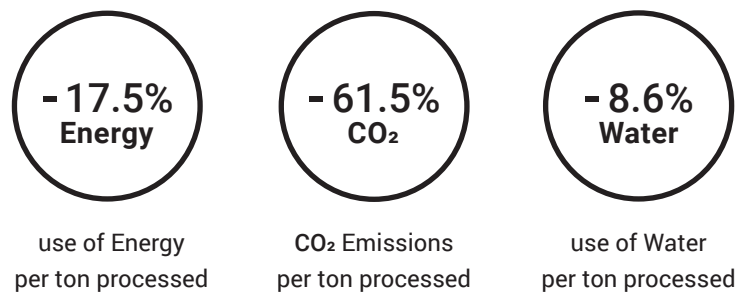

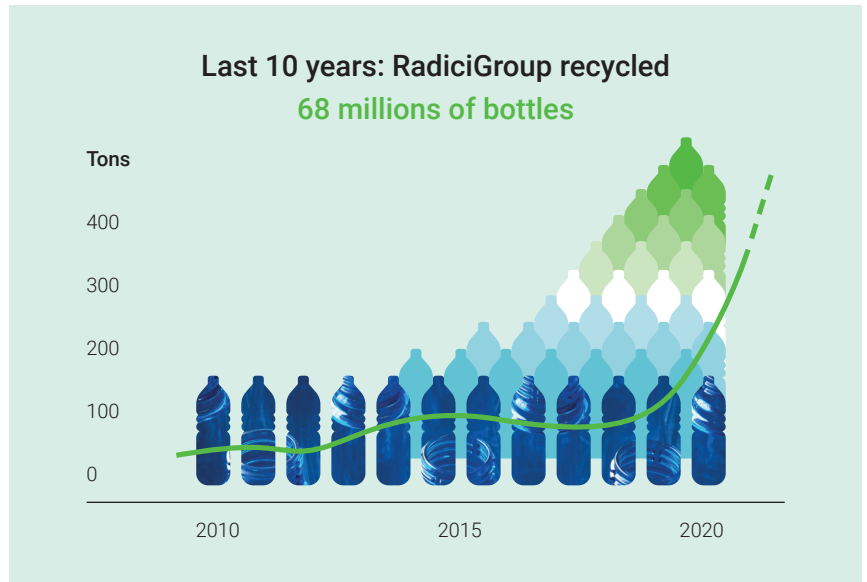

This led to the creation of Repetable®, a sustainable product obtained from post-consumer recycled PET Bottles with optimal performance for a variety of applications.

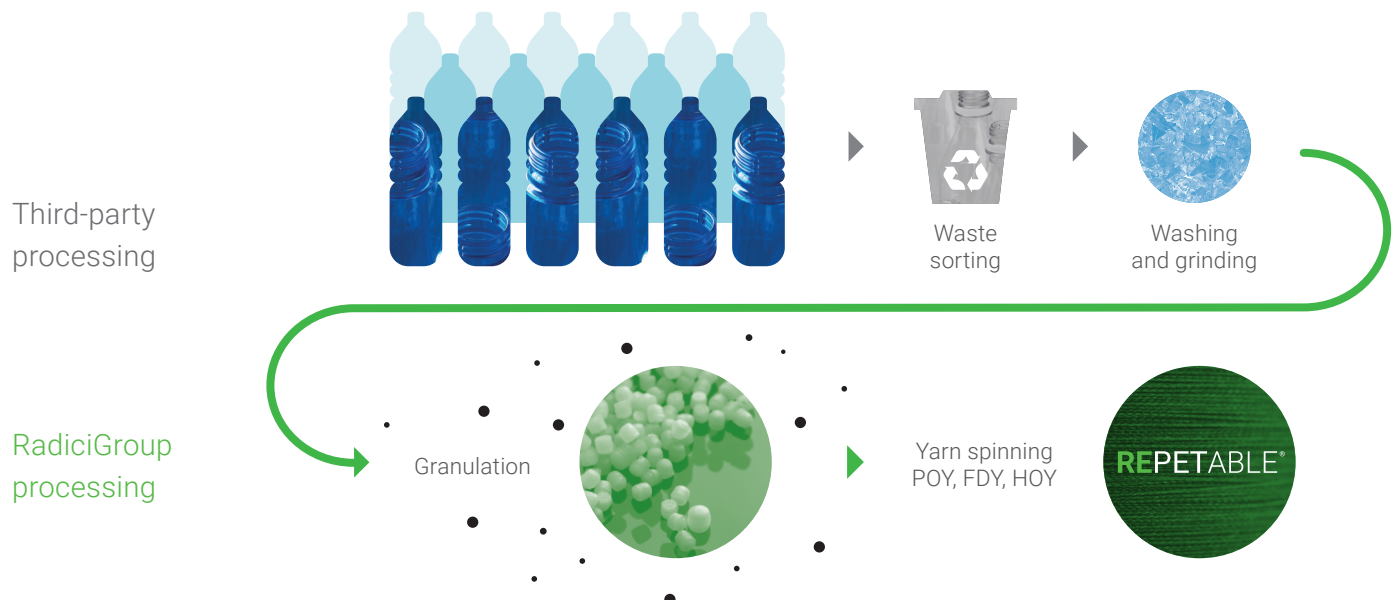

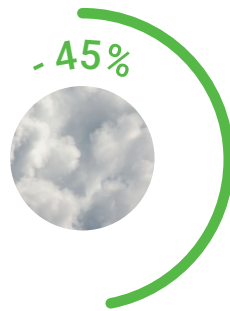
